21,000 spent of SSAP budget

20,000 left of SSAP budget: Could not hire two additional aides, using optional plan of two chrome carts with chrome books and plugs. Unanimous decision to implement optional plan of purchasing throw chrome carts.

Safe Technology and Digital Citizenship implementation plan (30min)

After reviewing effective schoolwide completion of this requirement, a virtual assembly presentation was unanimously decided on. This virtual assembly is to be viewed on February 18^{th} @ 9:00 am in all in-person classrooms, and available for all distance learning classrooms to implement into their schedules for that same day.

To bring parental awareness to Digital Citizenship, use of NetSmartz Parent Timely Tips will be distributed monthly to the community via: email, school website and Facebook page, PTA Facebook page, physical flyer to in-person students, and digital flyer to teacher classroom websites for distance learners.

- Parent tips to be distributed the last week of each month, with the first to be sent out end of January as an intro to Digital Citizenship and connection to the NetSmartz virtual assembly on February 18th.
- To create awareness that an email was sent out to community, a follow-up text message will be sent to encourage and make aware that an email was sent and to look over it.

Positive Behavior Plan Review and SSAP Brainstorming (15min)- Mr. Graham

The School-Wide Behavior Plan is part of the PBIS (Positive Behavior Interventions and Support), the SST (Student Study Team) consists of administrators and faculty at Arcadia Elementary and is active in supplying the intervention, reporting and discipline needs for the School-Wide Behavior Plan.

- Current positive behavior initiative: each student that follows rules for good behavior receive token/ticket which is then placed inside a container inside the lunch room. Each Wednesday is a drawing from this token/ticket pool, and recipients given rewards. (Arcadia's School-Wide Behavior Plan for community access should be on the school's website).
- Concern about Bennion Jr. High bus's stop located in front of Arcadia. The Jr. High students are becoming rowdy and disrespectful to Arcadia's students, faculty and administration. Arcadia faculty is being placed out by the bus stop to monitor behavior for the continued safety of Arcadia students. Recommendation to send email to Bennion SCC requesting they add to their Behavioral plan to accommodate bussed students and what behavior is acceptable, appropriate and respectful at bus stop locations, and school properties. Christina will work on creating and sending out an email to Bennion's SCC.
- Council is asked to be aware of anything that may need attention in this coming school year's School-Wide Behavior Plan (2021-2022).

SSAP 2021-2022 brainstorming:

- Anticipated 20,000 LAND Funds to work with
- Focus on Reading and Math
 - Four aides for the school year
 - Classroom supplies to support reading and math success
 - Council members to brainstorm supply ideas for reading and math success in the classrooms and bring those ideas to next month's meeting.
