Welcome:

- * **Community Council meeting started at 1:30 pm**

Agenda:

- * **Approval of February Minutes**
Kim motioned to approve minutes from February. Allison seconded the motion. Motion passed.
- * **LAND Trust 2014-2015**
LAND Trust money for 2014-2015 will be spent down to zero by the end of this school year. The progress report was approved with the change of Ed's email address and adding phone numbers for the Community Council members.
- * **LAND Trust 2015-2016**
The total for 2015-2016 is \$32,400. Mrs. Ward has asked for 5 Chrome Books for her classroom. The cost for this will be around \$1500. Kim mentioned a \$500 grant from Granite District Credit Union for special needs kids. Kim will get with Rebekka and they will talk about it. Kim said she would be willing to help write the grant. Suggested using LAND Trust money for teachers again but only for the purpose of raising test scores. The increase goals are as follows: English 5%, Math 5% and Science 10%. Deadline for submitting the 2015-2016 plan is March 27. Motion to approve 2015-2016 LAND Trust was proposed by Kim and seconded by Marty. Motion approved.
- * **Enrollment**
Enrollment is now in the low 500's. All registration cards have been put on the computer. It appears that 9th grade will be our lowest number.
- * **Proposed Verizon Cell Phone Tower**
Terri met with the people from Verizon about installing a cell phone tower just south of the basketball courts. Churchill will receive money up front (approx. \$40,000) and then a monthly amount after that. There is a chance that the tower can interfere with the headsets and other equipment in the auditorium because it is so out of date. Terri will check to see if Verizon would also be willing to update some of the auditorium headsets etc. This proposed cell phone tower must be presented to and passed by the Mount Olympus Community Council as well as the CJH Community Council. Community Council members will think about it and we will discuss and vote at the next meeting.
- * **Grade Level Configuration/Skyline Network**
Discussion of moving the 6th grade to the Jr. High. Eastwood, Oakridge, Morningside are all bursting. It is OK with the district if it is OK with the community. Can we also include Canyon Rim? Sixth grade could have their own hall where they would be assigned lockers and hopefully most of the teachers can be in that same area. It is definitely doable.
- * **Other Business**
Kim mentioned the Sorensen Grant for the Arts. She would be willing to write the grant for us ☺
