## Cyprus High's Proposed Dress Code

Cyprus High School's dress code supports equitable educational access and is written in a manner that does not reinforce stereotypes. We expect that all students will dress in a way that is appropriate for the school day. Student dress choices should respect the school's intent to sustain a community that is inclusive of a diverse range of identities. The primary responsibility for a student's attire does not contribute to a hostile or intimidating atmosphere for any student. Dress code enforcement will not reinforce or increase the marginalization or oppression of any group based on race, sex, gender identity, gender expression, sexual orientation, ethnicity, religion, cultural observance, household income, or body type/size.

### Minimal Requirement

- Clothing must cover areas from top of one armpit across to the top of the other armpit to mid-abdomen and from the waist to mid-thigh. Clothing must be connected from front to back over the shoulders. The fabric must cover up to the mid-abdomen with equal amount of cover on sides and back.
- Students must wear clothing with no see through fabric unless it is worn with appropriate coverage underneath that meets the minimum requirements of the dress code.
- Shoes must be worn at all times.



### Additional Requirements

- Clothing must not depict, imply, advertise, or advocate illegal, violent, lewd conduct, weapons, the use of tobacco, marijuana, alcohol, or other controlled substances.
- Clothing must not depict or imply pornography, nudity, or sexual acts.
- Clothing must not display or imply vulgar, discriminatory, or obscene language or images.
- Clothing must not state, imply, or depict hate speech/imagery targeting groups based on race, ethnicity, gender, sexual orientation, gender identity, religious affiliation, or any other protected classification.
- Clothing and accessories that endanger students or staff must not be worn.
- Apparel, jewelry, accessories, tattoos, or manner of grooming that, by virtue of its color, arrangement, trademark or any other attribute, denotes membership in a gang that advocates illegal or disruptive behavior is prohibited.
- Any items that obscure the face and ears except as a religious observance or as personal protective equipment (PPE).

The administration reserves the right to determine what constitutes appropriate dress. Students who break the dress code will be asked to change into suitable attire that will be offered at the front office. Parents will be called if appropriate clothing is not available or the student refuses dress-code appropriate clothing.
