- 2. Minutes Reviews and Approval from January Meeting Motioned to approve – Lance, Seconded – Becky
- 3. Upcoming Events
  - a. End of  $3^{rd}$  quarter is March  $14^{th}$ 
    - Parents & students should review grades for completion and accuracy
    - 3/14 "3<sup>rd</sup> Quarter Hang Out Day" (Last hour of the day, PM assembly schedule, a chance for all students to socialize and interact; organized by SBOs)
  - b. Hold March SCC to Vote on plan for next school year
    - Date change to 3/14 to be able to do Land Trust by the deadline (3:30p-4:30p)
- 4. <u>Safe Walking Routes</u> Review
  - a. Concerns
    - Federal regulations say that within 2 miles, students/families in secondary schools must find their own transportation; over 2 miles away, students may be bused in
    - Chris Griffiths showed UDOT map detailing GPJH boundaries and where there are stop signs and traffic lights that aid in safe walking routes
    - It was suggested to request school zone signs with flashing lights for 200 E on either end of the school and main crosswalk

- GSD is working with United Way to get additional supports; GSD is encouraging families to carpool
- Next year GSD will be going to bus passes (show your pass to ride the school bus)
  - Chris Griffiths is very open to any student riding the bus, as long as there are no safety issues
- GSD is looking into putting digital signs on buses, so bus switches aren't as confusing for kids
- Parent concern Bus switches/times are changed with little notice, which makes things a challenge for families
- Transportation issues all fall under the Transportation Department
- Supervising buses is challenging GSD is trying to crack down & help make things safer for kids
- b. Missing information
  - UDOT map is outdated

## 5. Review exiting Trust Land Plan

- a. Reading program GPJH has 1 reading specialist (with 2 more who will be endorsed as of next school year), it's a great program, Tier 2 strategies are successful, but we need Tier 3 supports as well (1-2 class periods of <24 students each)</p>
- b. Explanation of tiers: Tier 1 is regular ELA instruction and should be sufficient for approx. 80% of students; Tier 2 is interventions, extensions, reading comprehension, fluency, literacy skills, etc. beyond the regular ELA instruction; Tier 3 is SpEd services, 504 plan, IEP, etc. (smaller class sizes, etc.)
- c. Explanation of the "extra teacher" to be hired as part of the Land Trust Plan – Next year would be the same teacher hired as this year (we'd be retaining them), not a new additional teacher on top of what we currently have. Without LTP, we'd possibly have to surplus an English or Elective teacher
- d. Last year tests weren't normed, so they're not as accurate. GSD switching from Growth Measure to a different diagnostic that can aggregate data as desired.

- 6. Discuss Goal for next year
  - a. Continue with reading goal
    - RISE tests have limitations (some cultural bias) Reading classes will help with even the Math (mostly word problems)
    - Currently working move kids to "at grade level" or above
  - b. Change goal and ideas
    - Math interventions students struggle with Math the most on RISE
      - What does an intervention in Math look like? How can it address the needs of all students (who are at varying levels on different Math skills)?
    - Consensus: Change to a growth goal rather than a reaching proficiency goal (i.e., At least 500 students make at least a year's growth on XYZ test)
      - Reflects more of our students' strengths
      - Will help build their confidence
      - Motivating rather than demoralizing (for making a lot of growth and still being in the "Below Proficiency" band)
