Approval of minutes from January 4 was unanimous by SSC.

1. Welcome, introductions, and approval of Jan 2021 minutes (10 mins)

2. Principal Time—(10 min)
 - a. Land Trust/TSSA budget report

Has a remaining balance of 34,112.88 in Land Trust budget. The TSSA budget remains at 84, 856.52. We are paying a teacher an hourly wage out of TSSA. Currently we have 1/5 doing distance learning and 4/5 of students face to face learning. Starting term 3.432 face to face and 123 distance learners. The total student count is 556. The projected enrollment will be available in March.

The TSSA budget money will roll over to 2021-22 school year. Land Trust estimated to be 68,000. 120,000 is predicted for 2021-22 school year in Land Trust/TSSA budget.

- b. Valentine's Day Plan

PTA will be handing out a goodie bag for each face to face student on 11th of February. Teachers may or may not decide to do an activity with their class.

3. Dress Code Subcommittee report and discussion (5 min)

Sarah Geertsen gave an update on Dress Code. The dress code has been updated to proper shoes for P.E. and allowing flexibility for sandals and flip flops, hats and hoodies hoods should not be permitted during class time unless school sponsored; leggings have been changed to allow due to change of fashion. Updates to clothing for midriffs, underclothing.

The dress code states that students will not be sent home but sent to the office. Parents will be contacted to bring additional clothing for violations of dress code.

It was suggested to have video produced for student and parents to view and to have it ready for the end of the year.

Added to PBIS team agenda to create an inhouse video of dress code expectations, including how to wear a mask appropriately.

Recommendations for use of Land Trust and TSSA money: Pay teachers for additional Professional Development for teachers, Paraprofessionals, and Chromebook replacement. One item will be opened up for technology support. Next month we will create Land Trust plan for 2021-22 school year.

Dr. Longberg suggested to move SCC meeting from March 1 to March 8 to discuss staffing plan and Land Trust/TSSA for 2021-22 school year. Marie Porter stated the motion and seconded by Sarah Geertsen.

Sara Geertsen asked an update on Focus Groups. Messaging will be going out on Wednesday, February 3. The first focus group will be on February 23rd.

Sabrina Felsted explained that a parent flyer will be going home with a QR code to sign up for the focus group and explanation of the focus group. It was suggested to make the topics more specific for the focus groups.
