Item 3: School Level Plans-

- SSAP/Land Trust- Change in procedure: All schools have a SSAP Plan. It must be reviewed by the Community Council but approved by the school level Principal. This plan includes school goals selected using generated test data. The plan includes goals in areas such as commitments to students with disabilities, tools used for literacy instruction, behavior supports, school wide communication methods, etc.
