New Business:

- 1. Ryan Oaks:
 - a. The Utah Office of Education awarded Hunter High as one of three schools with exemplar work with ESL and ELL students.
 - b. HHS students have been awarded \$5 million worth of scholarships
 - c. Masks will not be required the last 2 days of schools, which will include graduation. There will be a Senior dinner and dance Saturday night with no tickets or restrictions.
- 2. Community Council elections for the 3 parents whose terms are up will be held online Sept 14-16
- 3. Department Academic Advisor payments were revised due to the attendance logs, and payments are approved to be made.
- 4. Afterschool Labs payments were revised due to attendance logs and payments are approved to be made.
- 5. Teacher's summer PLC/PBG work training. Teachers can work in the summer with their PLC groups; 3 days, 4 hours each day for a total of 1 hours @ \$200/day
- 6. AP payment amount from community council will be less than usual. The goal will be to incentivize the students, lower the costs, and start motivating students to take AP as early as 8th grade.
- 7. Professional development leadership team will have their last meeting on May 19th. Next year's schedule will not be a rotating A/B class schedule. Instead, A-day will be M/W, and B-day will be T/Th. Fridays will alternate between A/B, will be the late start day, and also assemblies will be scheduled for Fridays.
