KEARNS HIGH SCHOOL DANCE COMPANY GENERAL INFORMATION

TIME COMMITMENT:

Participating in Dance Company includes 4th period during the school year, summer rehearsals during the month of August, a 3-day summer dance camp during the month of August, after-school rehearsals and technique classes during the school year, as well as performance opportunities such as assemblies, sporting events, dance concerts and the annual Granite School District Dance Concert.

FINANCIAL COMMITMENT:

The approximate cost for participating in Dance Company is \$250 for the summer dance camp, \$150 for costume items and activities, and up to \$300 for optional items such as camp wear, bags, warm-ups, shoes, etc. We will be providing fundraising opportunities throughout the year for both optional and required costs.

ACADEMIC COMMITMENT:

Grades and attendance in school will be closely monitored. Students will be required to reach a 3.0 Grade Point Average with no "Fs" and a 3.0 Citizenship Point Average with no "os to maintain membership on the company.
