II. Last Month's Meeting Notes	Motion to Approve March Minutes -Barbara; Michelle 2nd motion; All approved.
III. Community Council Elections for next year	Four open positions - two employees -teachers - Zoe Bowen & Jennifer Oettli replace Barbara Luka and Karen Oliver. In fall have elections for Community Council so incoming parents have an opportunity. Back to school night will have posters, etc for community council.

Granite School District Full-Day Kindergarten 2021/22 School Year





2021/2022 Optional Enhanced Kindergarten Teacher List

Program Overview:

Granite School District provides full-day kindergarten sessions through the state-funded Optional Enhanced Kindergarten (O.E.K.) program. For the 2021-22 school year, Granite School District will be funding an O.E.K. class in 44 schools. Twelve of the participating schools are funding extra sessions of O.E.K. using additional school funding sources.

Full-day Kindergarten programs target "at risk" students, therefore, students are placed in a full-day class using the state-mandated Kindergarten Entry/Exit Profile (KEEP) assessment. The purpose of these full-day sessions is to provide more intensive instruction for our at-risk population and ultimately close the achievement gap leading into 1st grade. The full day teacher can double the amount of foundational instruction for these at-risk students, thus providing them a better opportunity to "catch up" to their peers. O.E.K. data is recorded and sent to the State Board of Education each year for program evaluation and effectiveness.

District Guidelines:

1. Registration:

Schools will assess students entering Kindergarten using KEEP Entry assessment.

Do not supplement the test with other tasks (i.e. writing their name, cutting with scissors, BOY Acadience)

Student scores are uploaded into the Data Gateway system. After compiling results of the KEEP, principals will place the "at risk" students in the full-day classes.

Open Enrollment Permits are not allowed for O.E.K. placement. Our full-day O.E.K. program serves students/families most at-risk based on the school's demographic profile. Therefore, families must live within the boundaries of a neighborhood school offering O.E.K. to be considered for placement in these full-day-classes.

2. Percentages:

Granite School District recommends "75-100%" of students placed in O.E.K. classrooms be identified as "at-risk." It is up to the discretion of the principal to determine the

exact number of students to place in O.E.K. Some principals prefer to have 100% "atrisk" students in O.E.K., while others staff those classes with 75% "at-risk" students.

3. Class Size/Move-ins:

When placing the students at the beginning of the year, place students scoring low on the KEEP assessment in full-day classes. You may leave a handful of spots open for students identified as at-risk after completing the KEEP assessment in the full-day classes. As the year progresses, if there arises a vacancy in a full-day classroom, it is recommended that you only place students in those openings who have attended a full-day kindergarten prior to moving to your school.

Please maintain balance in appropriate class size between both half and full-day classes, one not having too many more than the other.

4. Full-day Kindergarten and SEP Conferences:

O.E.K. teachers will follow the same SEP conference schedule as the 1st through 6th grade. Class time during SEP conference week will not be canceled for full-day kindergarten students. Full time teachers (teaching 2 half-day sessions) are allowed one full day of conferencing (student non-attendance day), and two evenings. Full-day kindergarten teachers will be given only the two evenings to conference, thus following the same schedule as the other grades.

5. Teacher Quality/Accountability:

As a District, our expectation is that you put your most-effective kindergarten teachers in these full-day kindergarten positions. Regardless of intentions, class sizes, etc, the success of the students in our full-day classrooms will depend on the quality of instruction. We will monitor OEK classrooms closely using Acadience, and the KEEP Entry/Exit assessments, expecting the children in your full-day classrooms to be making great strides.

It is required that full-day classroom instruction includes both literacy and math small group instruction daily.

Our district Kindergarten Specialist will be visiting classrooms and giving assistance to support your kindergarten teachers. Please feel free to contact her at any time if you have questions or concerns.
