INTERVENTIONS

Classroom Behavior Interventions

- Praise
- Precision Requests
- One Minute Skill Builder
- Role Plays
- Eye Contact
- Proximity/Shoulder touch
- Purposeful Ignoring
- Error Correction- Think Time

CONSEQUENCES

Classroom Consequences

Must:

- Verbal Warning
- Name in Behavior Log

Options:

- Seat Away
- Loss of Privileges/Recess
- Clean-up Duty
- Apology

Level 2-MINOR

BEHAVIORS

MORE SERIOUS, DELIBERATE OR INTENSE BEHAVIORS

Classroom behaviors 3 times within a day (see Classroom list)

Minor Behavior Interventions

- Behavior contracts
- Parent conference
- Behavior Education Plan (BEP)
- Strategic Seating
- Strategic Breaks
- Specific Grouping
- Error Correction
- Think Time
- Teaching Replacement Behaviors

CONSEQUENCES

Minor Consequences

Must:

- Minor Behavior report in Ed Handbook
- Call to parents

Options:

- Verbal Correction
- Seat Away
- Cross grade Time Out
- Loss of Privileges/Recess
- Clean-up Duty

Level 3-OFFICE

BEHAVIORS

- *Chronic Minor Behaviors
- Minor behaviors 3 times within week or
- *Physical Aggression/Fighting
- *Abusive Language/ Profanity
- *Property Damage /Vandalism/
- *Bullying /Harassment/ Intimidation
- *Forgery/Theft
- *Possession of weapons
- *Illegal substances
- *Other

INTERVENTIONS

Office Behavior Interventions

- Behavior contracts

- Scheduled breaks
- Social Skills Instruction
- Teaching Replacement Behaviors
- Team Referral

Office Consequences

Must:
