- 1. Minutes from the last meeting were approved.

- b. Granite School District has not addressed the issue of Upland's concerns.
 - i. Upland families want to know what will happen to the sixth grade special education classes.
 - ii. Options and concerns were discussed.
 - iii. Upland needs to request that the Board review their concerns with the Superintendent.
 - iv. Skyline High Council wants to be supportive.
- c. There were some complaints that the survey results meeting was too early.

4. Construction/Facilities

- a. The roof of the graphics building and room will be repaired.
- b. The main gym floor will be sanded down, repaired and refinished.
- c. Skyline is on the list to be rebuilt.
- d. New display cases will be ordered and placed near the auditorium.
- e. Senior class pictures will be moved to the Performing Arts hallway.

5. Staffing

- a. Need a financial teacher who must have an MBA to teach SLCC concurrent classes and high school classes.
- b. Linda Sossenheimer will move to an intern counselor position so the IB office aide position will become available.

6. Elections for Community Council

- a. Any Council members who have served for two years will have to re-apply to be on the council. Elections will be held in September during parent-teacher conference.
- 7. The next meeting will be held after the first of the school year.
