Review Minutes From Last Meeting – Janie

• Title 1 Plan Revisions Approved Last Month was submitted – Ernie

Land Trust Revision – Ernie

Our original budget plans for LAND Trust funds need to be amended to accommodate the shortfalls in the Title 1 budget and allow us to maintain a high level of support for literacy and math interventions for our students at risk. We are asking for your support on moving money that was originally allocated for library books, general supplies and technology be reallocated to salary/benefits for intervention aides that will serve our students needs directly in the classroom.

Review 2017-18 SSAP – Ernie

Highlighted growth goals of 10% increase in Math, 12% increase in Language Arts, and 15% increase in Science SAGE year-end proficiency scores. Outlined plan to achieve this goal.
