HVAC Construction Presentation:

Don Adams had a presentation prepared. We are doing this project because of a need for HVAC improvements, air quality improvements, and for other improvements. Currently, we have a special source of funding that must be spent by November 2024. The cost would be extensive, 5-6 million dollars. To be able to upgrade it will take 10-11 months. It will include HVAC, classroom upgrades, and hallway upgrades. Classes will be in relos for 3-4 months in a relo. Teachers will get help moving items. Gymnasium and kitchen will be open all year. Providing additional restrooms. The library and staff areas would be closed all year. The beginning area would be the south hall, followed by the north hall, and then the gym, cafeteria, and offices on the front of the building. Relos will be brought in the back of the school and on the south side of the school.

Parent concerns: Ellis brought up that Truman used to be a temporary school. How are the bones of the school? Truman was built with a solid wood frame. The HVAC team said this is not a "temporary" school. The HVAC expressed issues in the floor can be remediated as the project continues.

Karyn Winder expressed the school board has not officially approved this project. Mentioned concerns brought up about special education classes. There is a boundary study happening next year. Truman has 300 students. Is it worth it to upgrade at this point? The explanation contained the fact that the building could be used for other things in the future and this building is a good option. Also, no one knows what could happen with Truman based on the study. The board is looking at the building conditions in making a determination. The board was made

aware last week. Next week the relos will be addressed with the board. Also expressed community and community pride and the impact of construction.

Dr.Nye: Expressed concerns over making the least impact to students. On the other hand, he has considered how inefficient our school HVAC must be.

Valerie and Becki said they support the project. Becki expressed that the aesthetics of the school could help grow Truman's population. Eliis Rygg expressed concerns over the time involved for teacher meetings etc. Mrs. Rygg expressed concerns over being a parent and having a fifth grader who will not benefit from the construction. Mrs. Rygg is concerned about the library and the team has considered media center shelves that move.
