- Distance Learning Update
 - 288 Students are signed up as distance learners for 1 or more periods
 - 769 total students 37.5% of all students
 - Added supports
 - Intervention efforts
- Covid Precautions and questions
 - Masks are going well but we all experience mask-fatigue
 - District believes school spread is less than 3%
 - Spike in community in past two weeks includes VJH
 - Discrepancy in dashboard and reported numbers
- Action Item: LandTrust Plan amendment
 - Plan originally was to have full-time social worker
 - Unable to hire a qualified SW
 - Proposal to shift funds to teacher pay for:
 - FTE shortfall (2.75% FTE or approx \$2,000)
 - Leadership Team support time (\$6,000) and extra period pay for distance learner teacher "prep buyout" (\$30,000)
 - Any additional funds available will be allocated towards technology (chromebooks) as previously decided upon
- TSSA Adjustment to mirror loss of social worker addition and pay to go towards Distance Learner prep buyouts as well as technology to support Distance Learners
